Massachusetts Police officer sentenced for punching man in custody multiple times without justification

"

BOSTON — A former Weymouth Police officer was sentenced today for assaulting a man in custody by punching the victim multiple times without legal justification.

Justin Chappell, 43, was sentenced by U.S. District Court Judge Allison D. Burroughs to two years' supervised release, with the first six months to be served in home confinement. Chappell was also ordered to complete 40 hours of community service per year of supervised release, for a total of 80 hours. In April 2024, Chappell pleaded guilty to one count of deprivation of rights under color of law.


On July 2, 2022, Chappell was a police officer for the Weymouth Police Department. While on duty, he responded to a call regarding an allegedly intoxicated man causing a disturbance at a home in Weymouth. Chappell placed the man under arrest, and while attempting to put the man in the police cruiser, Chappell punched the man approximately 13 times with a closed fist without legal justification. The punches caused obvious pain and visible injuries to the man's head.

Acting United States Attorney Joshua S. Levy and Jodi Cohen, Special Agent in Charge of the Federal Bureau of Investigation, Boston Division made the announcement today. Valuable assistance was provided by the Weymouth Police Department and the Norfolk County District Attorney's Office. Assistant U.S. Attorneys Torey B. Cummings and Neil J.

Gallagher Jr. of the Criminal Division prosecuted the case."-Massachusetts Deaprtment of Justice.

Massachusetts To Receive \$1.72 Billion in Federal

Funding for Cape Cod Bridges

Today, Senators Elizabeth Warren and Ed Markey, Congressman Bill Keating, and Governor Maura Healey announced they have secured a total of \$1.72 billion for the replacement of the Cape Cod bridges. This is in response to last week's announcement that Massachusetts was awarded nearly \$1 billion from the Bipartisan Infrastructure Law's Bridge Investment Program (BIP). This builds on the previously won \$372 million from the federal Multimodal Project Discretionary Grant program, in addition to \$350 million secured by the congressional delegation from FY24 appropriations. Governor Healey has also committed \$700 million in state funds to the project.

Vineyard Wind Searching Nantucket Beaches For Blade Debris

Vineyard Wind will deploy teams to search Nantucket's southern beaches for any debris that has washed ashore after one of its offshore wind turbine blades was damaged.

The company announced Tuesday morning that it would embark on new efforts to clean up pieces of fiberglass that might land on Nantucket and, with the help of the U.S. Coast Guard, maintain a "safety zone" of 500 meters around the impacted turbine about 15 miles away from the islands.

Vineyard Wind still has not publicly identified what caused the problem, describing it only as a "blade damage incident that took place on Saturday, July 13, 2024." A spokesperson for the company said Monday that GE, which manufactured and installed the turbine blades, is investigating.

So far, the company said Tuesday, crews have recovered "three large fragments" from the damaged turbine blade. The Nantucket Current published photos Monday evening of larger turbine pieces floating in the water.

Vineyard Wind plans to continue monitoring the offshore area with "aerial overflights and vessel patrols" to monitor for any additional floating debris.

Any blade pieces that could land on Nantucket's southern beaches will likely be "pieces 1 square foot or less," Vineyard Wind said. The company urged any beachcombers not to move debris themselves and instead to contact Ian Campbell at (781) 983-8943 or icampbell@vineyardwind.com, or to report the location online.

"The debris consists of non-toxic fiberglass fragments ranging in size from small pieces to larger sections, typically green or white in color," Vineyard Wind said, adding, "Although the fiberglass fragments are not hazardous to people or the environment, Vineyard Wind recommends that only its employees or contractors collect and remove the debris."

Search teams will inspect beaches in the morning and evening, with plans to visit Miacomet Beach, Nobadeer Beach, Madequecham Beach, Pebble Beach, Tom Nevers Beach, Low Beach and Sconset Beach "or other areas where debris may wash ashore." The company will deploy two teams of four people each for "several days."

Vineyard Wind, the joint venture between energy giant Avangrid and Copenhagen Infrastructure Partners, is the first major offshore wind project delivering power to the regional energy grid. So far, the 10 operational turbines are delivering 136 megawatts, and project officials plan to ramp that up to 62 turbines offering a combined 806 megawatts.

City of New Bedford performs 33 clean-ups of blighted properties

"When landlords allow their properties to fall into disrepair and become blight on the neighborhood, the City may come in after necessary notice and clean the property, and then place a lien on it. In Fiscal 2024, the City performed 33 of these clean-ups and placed \$31,763.34 worth of tax liens against the owners.

In June, for instance, the City performed clean-ups at four properties across the City, placing a combined \$3,575.39 in tax liens against the property owners. The cleanups were located at:

- South Side Scott Street Parcel 20 268 \$1,074.40 liened to owner Ali Murad in Buffalo
- 13 Durfee St. Parcel 77 375 \$1,106 liened to SUMDRU Inc., President Anthony Cristaldi
- 1227 Ashley Blvd. \$519.44 liened to Daniel and Tracy Schrier of Schrier Living Trust in Rancho Palos Verdes, Calif.
- 558 Mt. Pleasant St. \$875.55 liened to Leisure Industries C/O Mike Rocha in Fairhaven

While the vast majority of landlords in New Bedford maintain

and care for their properties, the City will continue to hold irresponsible absentee landlords accountable for letting their properties turn into neighborhood blight."-City of New Bedford.

Bristol County Sheriff wants to close New Bedford's "money pit", Ash St. jail

"Due to some falling bricks and other easily observable façade issues, in order to get an annual occupancy permit, the BCSO was ordered by the district state building inspector to have a structural engineer assess the Ash Street Jail in New Bedford. My administration complied with that order.

The report below provided to the BCSO report shows that

the band-aid fix is about \$35,000.

However, to properly fix the structural issues with Ash St. is over \$3.8 million.

It would not make sense to spend \$3.8 million on a facility that costs us about \$5 million a year to run. It makes more sense to consolidate resources at the Dartmouth jail campus.

On 18 June, 2024, I asked the state delegation of Reps and Senators who represent all or some of Bristol County to support a several phase plan to close Ash Street. That email is copied at the bottom of this email.

State Representative Chris Markey quickly told me that he would file what is needed to make the plan to close Ash St a reality. Other Reps and Senators have also pledged their support.

The steps to close Ash St and the benefits of closing the Ash Street Jail are detailed in my email to the state delegation, found below.

Let me know if

REPORT:

"Hello, State Senators and State Representatives,

I am writing to you today asking for your assistance in **closing Ash Street jail** in New Bedford; it is a money pit and taking resources away from the Dartmouth campus.

The Ash Street jail has three types of people: 1) regional detainees, 2) sentenced inmates, and 3) awaiting trial inmates. I cannot close Ash Street unless I bring all three categories back to Dartmouth due to staffing issues.

The general plan follows the following steps.

- 1. Receive appropriation from the state to hire a firm to redesign a retrofit for an unused kitchen on the campus in Dartmouth to accommodate the *regional detainees* who are currently held at the Ash St jail.
- a. Why do we need to do this? The unused kitchen would be retrofitted to put 'holding cells' to be used only for the regional detainees. A regional detainee is a person arrested by a local police department, delivered to us, and then held at my jail on Ash St in New Bedford in the regional lock up and held until the detainee can appear before a judge in court the next business day. We hold regional detainees for 19 of the 20 cities and towns in Bristol County who routinely utilize our regional lock up. We need to relocate this operation from New Bedford to Dartmouth in order to improve safety and save money.
- 2. With the new design in hand, we now also have a dollar amount on how much the retrofit would cost, which our in-house estimate is around \$3-4 million.
- 3. Receive second appropriation from the state to build the regional detainee holding cells. This is done by a private contractor with DCAMM oversight. There is no net gain in cells.
- 4. Move the
- a. 10-20 or so 'regional detainee operation' to the newly constructed cells in Dartmouth.
- b. 80 or so regular inmates from Ash St to Dartmouth and

put them in existing unused housing units in Dartmouth.

5. Close Ash Street jail and regional lock up, and turn it back over to the state for sale to a private developer or some other yet to be determined use.

The estimated costs for this project are modest for the gains we get.

COSTS

Retrofit design done by a firm — approximately \$750,000

Construction of the new regional lock up at the Dartmouth campus — approximately \$3-4 million

RETURN ON INVESTMENT

\$700,000 each year won't be spent on utilities and other maintenance at Ash St in New Bedford

\$2-5 million for the sale of Ash St to a private developer

SAFETY ASPECTS

By relocating the regional lock up detainees (and the regular inmates) to the Dartmouth Jail, we bring 45-50 COs who regularly work at Ash Street New Bedford to the Dartmouth campus. By consolidating the security operation on one campus, we increase the security staff to inmate ratio, and we increase the amount of programming available to inmates at the Dartmouth campus, which helps with reentry decreasing recidivism. There is NO NET gain in cells; this plan reduces the number of BCSO cells by nearly 200.

SUMMARY — I am asking for your financial support to help me close Ash Street 1) in order to improve safety for all involved, and 2) save the state money by operating more efficiently on one campus.

New Bedford Police respond to "shots fired" on Acushnet Ave near Monte's Park
