Mitchell proposes four year term of office for future mayors

With his administration focused on New Bedford's long-term future, Mayor Jon Mitchell today presented the City Council with a proposal to modernize the term of office for mayor from two to four years. The modification, Mitchell said, would enhance the municipality's ability to build a stronger future for itself by promoting stability in its executive branch, encouraging its chief executive to focus on the city's long-term best interests and reducing the time diverted from governmental duties to campaigning and fundraising.

To avoid any suggestion that his proposal is motivated by personal political considerations, Mayor Mitchell also submitted a proposed amendment that would set the effective date of the act after the current mayor leaves office.

"If the council passes the amendment, I would not be eligible to be elected to a four-year term. This proposal is not about me, it is about the long term interests of the City we love," he said.

A change in the term of office for mayor requires an amendment to the City of New Bedford's charter. Mayor Mitchell has proposed the charter change as a Special Act which requires the approval of the City Council as well as the state legislature before it may take effect.

In a detailed letter to the Council outlining his proposal, Mayor Mitchell highlighted the serious disadvantages associated with the City retaining a two-year term for the office of mayor, "I believe that the adoption of a four-year term is necessary because the current two-year term impedes our ability to build the better future we all want for our

City, in that it (1) tends to undermine the general effectiveness of the executive branch; (2) skews policy and program initiatives toward narrow or trivial short term interests; (3) diverts time and energy to mobilizing campaign organizations and to campaign fundraising and away from important governmental duties; and puts New Bedford at a competitive disadvantage versus cities with more modern mayoral structures."

He pointed to the need for stability in the City's executive branch and with that the importance of devoting all of the mayor's attention and energy on the leading the city with a clear focus on the long-term. "That a mayor would be subject to a re-election campaign by the time he or she has just gotten up-and-running, in which the outcome may be the election of someone entirely new who would start the process all over again, is inherently destabilizing. Mayors serve the public best when they set clear, broad and achievable long-term goals and stay the course until they are realized. A four year term would significantly reduce the time necessary to campaign and to raise campaign contributions, which displace time spent governing," Mitchell said.

Nearly every major city in the United States has adopted a four year mayoral term. Once adopted, New Bedford would join the increasing number of Massachusetts cities with a four-year term for mayor including, Boston, Pittsfield, Quincy, and Springfield.

In addition, to allow voters more time to cast an absentee ballot, the City of New Bedford Election Office will open on Saturday, September 6, 2014 from 8:00 a.m. to 12 Noon.

In this election, voters will cast their ballot for Senator in Congress, Governor, Lieutenant Governor, Attorney General, Secretary of State, Treasurer, Auditor, Representative in Congress, Ninth District; Councillor, First District; Senator in General Court, Second Bristol and Plymouth District, Representative in General Court, 8th, 9th, 10th, 11th and 13th Bristol Districts, District Attorney for Bristol County, Register of Probate; Bristol County, County Treasurer and County Commissioner for Bristol County.

The deadline to register to vote in the State Primary is Wednesday, August 20, 2014. The Elections Office will remain open on August 20, 2014 until 8:00 p.m.

Wake up New Bedford (and the south coast)



Yesterday morning I headed over to the Democratic Gubernatorial Candidates Forum hosted by the New Bedford Democratic City Committee at the Zeiteron Theater. Five Democratic candidates fighting for the Democratic Party's nomination were there to answer questions. It was a big deal and I wanted to hear what they had to say.

It took 20 minutes to find parking at the streets were jammed with activity and the city's two parking garages were maxed. It was standing room only as 3,000 people tried to fill into the 1,200 or so seats at the Zeiterion Theatre. There was excitement in the air and the candidates were even seen peeking at the crowd from the red curtains that shielded them from view. These candidates were rock stars and whoever won the nomination would take New Bedford and the South Coast seriously.

Now let's step back into reality and review what really happened.

While I was excited to see the candidates, the turnout was dismal. The event started at 9 a.m., but due to prior commitments I showed up at 11 a.m. knowing that the candidates wouldn't start answering questions until around 11:30 a.m.

It was surprisingly easy to find street parking just one block away and the parking garages were empty. It was easy to find seating, even in the front row. In total about 150 people showed up (organizers claim 280) and that included local politicians, local media and of course the candidates' entourages. This group seemed to outnumber the everyday citizen and who the candidates were trying to win over. I'd estimate about 50-75 of these people showed up.



Let me explain why this matters and why this disinterest needs to change.

Candidates for governors are very smart people and the five I listened to today are some of the smartest candidates I've ever seen. They have great memories. This event was billed as a South Coast, Massachusetts event. That's a few hundred thousand people with New Bedford and Fall River alone being 190,000 people. It's all about the numbers with politicians. The South Coast area is known for low voter turnout and we just validated that with someone who has a great chance of being our future governor.

By its historical voting record, the people of New Bedford and

the south coast have already told Republican candidates, don't bother coming and now we've just told these five Democratic candidates that we are an irrelevant, disinterested people that only need attention because we are the #1 fishing port in America.

New Bedford has a history of parents uninterested in showing up to important school meetings. Earlier this year we had 15 and 100 people show up to two meetings with Superintendent Pia Durkin to discuss the turnaround plan at New Bedford High School with 2,600 students. Earlier this month "maybe 30 parents" showed up to the same style meeting to discuss the future of three middle schools. During last year's New Bedford elections, maybe 30 people showed up each night to the City Council and School Committee debates hosted at the New Bedford Whaling Museum.

There are lots of excuses to the low turnout to debates, important school meetings and elections. The ones I hear most often are people stating they didn't get the word or that they had prior commitments. This may be the case for many, but the sad case is I can walk into Market Basket at anytime of the day and find 300 people. It's a matter of priorities. If we want to be taken seriously by the politicians locally, we must show up to local debates and important school meetings. If we want to be taken seriously by the politicians statewide and nationally, we need to show up to important debates and vote when the time comes. These politicians have great memories and will make decisions that affect us based on our actions and even more importantly inactions.

Putting the New Bedford City Council's 44% Pay Raise in Perspective





On March 13th, Councilors Rebeiro and Carney posted a motion to the city council to repeal the 44% pay raise that the City Council voted for two years earlier. It caused some major friction in the City Council chambers as the other nine city councilors verbally beat up the two newly elected councilors.

To put the pay raise in perspective it was a bump to from \$14,600 to \$21,000 or a \$6,400 annual increase. That translates into \$533.33 per month or \$133 a week. It's politically advantageous to say 44% compared to a \$6,400 annual increase.

Apparently, only the city council can give themselves a pay raise and probably the reason they haven't had a pay raise since 1995. Can voting yourself a pay raise every be popular in politics? That's 17 years without a pay raise. I'm not a mathematician or an accountant, but let's examine the pay raise numbers using a compounded annual growth calculator. The growth from \$14,600 to \$21,000 over 17 years comes out to a compounded annual growth of 2.58%. You can see my work here.

Is it unreasonable to give a city councilor a 2.58% annual pay raise? I did a quick Google search and grabbed the first article that looked valid. According to **the article:** "From 2000 to 2008, the average pay increase was between 3.8 percent and 4.4 percent. Fast forward to the years from 2009 to 2011, and the median pay increase dropped to hover around 3 percent." The article goes on to say 1.9%-3.5% is the most recent going rate.

Take away the political rhetoric of the 44% number and look at the pay raise without emotion and the raise seems more than fair. You can argue that the pay raise was bad timing, but you can't argue that the raise was high when looking at it on an annual basis compared to the private sector.
