## New Bedford Snow Parking Ban - 21 January, 2013

The City of New Bedford has announced a snow emergency parking ban to take effect today (Monday, January 21, 2013) in residential areas as of 7:00 p.m. and as of 11:00 p.m. in the business districts. The parking ban will remain in effect for 48-hours thereafter, unless lifted or further extended by City officials. The parking ban is designed to allow City workers to efficiently remove snow from New Bedford roadways to allow public safety vehicles and residents to travel safely.

The National Weather Service in Taunton has issued a Winter Weather Advisory for Southern Bristol County. The forecast calls for accumulating snow developing late this afternoon or early this evening and continuing at times tonight before tapering off Tuesday morning. As of early this morning, the National Weather Service expects 2 to 4 inches of accumulation with a possibility of 3 to 6 inches near the South Coast.

While the snow emergency parking ban is in effect, parking is <u>permitted</u> on the side of the street that is <u>opposite</u> the fire hydrants. No vehicle should be parked on the same side of the street as a fire hydrant, <u>except</u> on streets that are regularly posted for parking on one side of the street only. In posted areas, residents are to obey the signs as usual.

In the business districts, a <u>double-sided</u> parking ban will take effect in both the Acushnet Avenue Business District and the Downtown Business District as of 11:00 p.m., on Monday, January 21, 2013 tonight. Downtown parking is available at no charge in the Elm Street and the Zeiterion Parking Garages.

<u>Violations of this parking regulation will be subject to ticketing at \$50 per ticket and towing at full cost to the owner of the vehicle towed.</u> The vehicle owner is also responsible for the full cost of storage for any towed vehicle.
